Keynote Speaker



William L. Lassiter, MPA Deputy Secretary, Division of Juvenile Justice and Delinquency Prevention NC Department of Public Safety william.lassiter@ncdps.gov | 919-825-2719

Mr. Lassiter plans and directs operations of the Division of Juvenile Justice and Delinquency Prevention and serves as a member of the Department's senior leadership team. As Deputy Secretary of Juvenile Justice, he oversees juvenile facility operations, juvenile court services, juvenile community programs, and juvenile intervention and treatment programs.

Mr. Lassiter received his master's degree in public administration from North CarolinaState University; and has spent his whole career working in juvenile justice and school safety and is devoted to creating safer schools and communities for all our state's youth.

Lassiter has co-authored <u>Preventing Violence and Crime in America's Schools: From Put-Downs to Lock-Downs</u>, which takes an in-depth look at the causes and solutions of youth violence. Due to Lassiter's knowledge of school safety, Gov. Roy Cooper appointed him as chair of the N.C. Task Force for Safer Schools in October 2019. This task force serves as an advisory board to the Center for Safer Schools, and provides guidance and recommendations to the Governor, Superintendent of Public Instruction, and the General Assembly to improve statewide policy to enhance statewide and local capacities to create safer schools.

In addition to the Safer School Task Force, Lassiter also serves on several other boards and commissions including: The Governor's Crime Commission, The Juvenile Justice Planning Committee, the Juvenile Jurisdiction Advisory Committee, and the Chief Justice's Task Force on Trauma-Informed Courts.

Mr. Lassiter was honored to receive the prestigious National Service Award from the Hamilton Fish Institute on School and Community Violence, for his exemplary service to children, youth, and communities. In 2020 he was named a Defender of Justice from the North Carolina Justice Center for his exemplary work on policy and research, which paved the way to North Carolina raising the age of juvenile jurisdiction.

Lassiter has been featured on a number of major news networks and national publications including CNN, Fox News, the BBC, USA Today, the Los Angeles Times, the New York Times, and many others.

Human Trafficking 101

Beverly Weeks, C.E.O. Jonathan Chavous, Cry Freedom Missions



Beverly Weeks is an energetic, Jesus-Loving "Girl Next Door." Her inspiring transparent messages are seasoned with a little laughter, candid real-life struggles, and filled with Biblical truths. Often people who hear her speak say the same thing, "She's Just SO real." She has a love for people that is fully evident both on and off stage.

Beverly is trained in Biblical counseling and is an ordained minister. She is an author and international speaker. As Executive Director of Wayne Pregnancy Center and Cry Freedom Missions, she leads a powerful team that Reaches, Rescues, and Restores Survivors of Sex trafficking. Through the jail and hotel

outreaches, CFM is able to help survivors find safety at the Cry Freedom Missions Home and therapeutic healing from the past. Beverly has also started Cry Freedom Missions Shoppe that provides employment for survivors and resources for the Mission. She is married to her best friend Rick who had no idea what he was getting into when he asked her to marry him. They have two children, Tyler & Macy and reside in Goldsboro. In 2008, Jonathan was introduced to the horrors of human trafficking in Peru, Japan, and the Philippines and began working to restore those who had been enslaved. In 2009, Jonathan helped form an organization to help children in human trafficking in the Philippines called Hope for All Children. The ministry formed a safe house to rescue victims and house girls 15 and younger. The Hope House has been operational since 2011 in Samal, Philippines. In 2017, Jonathan began work with Wayne Pregnancy Center to help develop Cry Freedom Missions. Jonathan has developed outreach programs, including jail outreach, hotel outreach, and homeless outreach. He has also worked to establish case management, awareness programs, and an emergency shelter. His passion has been to help those the

world would consider the least among us.

Reentry to Resilience (R2R): A Unique Pilot Project to Enhance Reentry Planning beginning at a youth's admission to YDC in NC

Debbie Dawes directs the Court Systems Research Program in the Applied Justice Research Division at RTI International. Ms. Dawes has more than 20 years of experience conducting juvenile and criminal justice policy analysis and program evaluations, particularly within the areas of pretrial, sentencing, probation, reentry, and system reform. She is the evaluation partner to the NC Department of Public Safety on its FY2019 OJJDP Second Chance Act grant where she leads a team studying the implementation and impact of an

innovative community-based youth reentry program. Ms. Dawes' other evaluation experience includes substantive roles on Second Chance Act adult reentry evaluations, the multisite evaluation of the Serious and Violent Offender Reentry Initiative (SVORI) and two long-term follow-up studies, a randomized controlled trial of the Honest Opportunity Probation with Enforcement (HOPE) Demonstration Field Experiment, the Arnold Ventures-funded Advancing Pretrial Policy and Research project, and the MacArthur Foundation's Safety and Justice Challenge. Before joining RTI, Ms. Dawes was on the staff of the North Carolina Sentencing and Policy Advisory Commission. As a research and policy associate, she facilitated the commission's development of research-based criminal and juvenile justice policy recommendations to the state legislature and other decision-making bodies.



Christal is a Licensed Clinical Mental Health Counselor, Licensed Clinical Addiction Specialist, Leadership Coach and a Success Strategist who is passionate about Juvenile Justice, leadership and mental health.

Christal was appointed by the Board of Commissioners to serve on the Juvenile Council for Crime Prevention and was selected to serve on the Executive Board. She was also selected by Communities in Schools of North

Carolina, one of the leading nonprofit organizations in the nation, to serve as director of youth development for ReEntry to Resilience, a program that seamlessly and successfully transitions at-risk youth from confinement back to their communities. Christal was selected by the National Council of Negro Women as the 2020 Woman of Excellence for her leadership in the community and is a 2021 recipient of the 40 under 40 award. Christal graduated with honors with her bachelor's degree in Psychology and master's degree in Clinical Psychology from North Carolina Central University. During her undergraduate years, she served as Miss Freshman, Miss Psychology and reigned as Miss North Carolina Central University. She is currently pursuing her doctoral degree at Arizona State University.
